Sealed Bids: Sealed Bids for the construction of the **Water & Sewer Improvements to serve A1 Industries of Georgia, LLC** will be received, by **Decatur County Board of Commissioners**, at the **Decatur County Administration Building, 203 West Broughton Street, Bainbridge, Georgia 39817**, until **11:00 A.M., Thursday, March 25, 2021**, local time, at which time the Bids received will be publicly opened and read. No bid may be withdrawn after the closing time for receipt of bids for a period of sixty (60) days.

Contractor License: Any Contractor submitting a bid must be a licensed Utility Contractor by the State of Georgia. License numbers must be written on the face of the bid envelope. No bid will be opened unless the license number is clearly shown. See Instructions to Bidders for additional bidding requirements.

Work to Be Done: The Work to be performed under this Contract shall consist of furnishing all labor, materials, tools, equipment and incidentals and performing all Work required to perform the construction of the project titled Water & Sewer Improvements to serve A1 Industries of Georgia, LLC to include installation of approximately $\pm 7,300$ linear feet of 8-inch and 12-inch PVC water main, with fire hydrants, valves, fittings, erosion control, NPDES monitoring, traffic control, and all other incidental items required for a complete project for the Owner. This work will be awarded in one (1) contract with a 180 consecutive calendar day construction schedule.

All bonds must appear on the Treasury Department's most current Circular 570 Listing.
