PRESENT: CHAIRMAN PETE STEPHENS, VICE CHAIRMAN DENNIS BRINSON, COMMISSIONERS, BOBBY BARBER, JR, RUSTY DAVIS, GEORGE ANDERSON, AND STEVE BROCK, COUNTY ADMINISTRATOR ALAN THOMAS, COUNTY ATTORNEY BRUCE KIRBO, AND COUNTY CLERK MICHELLE WEST

#### INVOCATION AND THE PLEDGE OF ALLEGIANCE

Chairman Stephens called the regular meeting to order at 7:00 p.m. After the call to order, Attorney Kirbo gave the invocation and all those assembled pledged allegiance to the flag of the United States of America.

#### **APPROVAL OF AGENDA**

Commissioner Davis made a motion to approve the agenda, as presented. Commissioner Barber seconded the motion, a vote was taken and unanimously approved.

#### SPECIAL PRESENTATIONS

There were no Special Presentations.

#### **PUBLIC PARTICIPATION**

Chairman Stephens recognized Willie Sapp who lives at 534 Cool Springs Road. Mr. Sapp spoke about the bad internet connection in the rural parts of the County and was hoping the Board could do something to help improve the internet reception.

#### **APPROVAL OF MINUTES**

Commissioner Barber made a motion to approve the minutes of the Commissioners' meeting held June 13, 2023, as presented. Commissioner Davis seconded the motion, a vote was taken and unanimously approved.

#### **OLD BUSINESS**

There was no Old Business.

#### **NEW BUSINESS**

Consider Approval of Resolution – FY 2023 – 2024 Budget. Chairman Stephens recognized County Administrator Thomas who stated the resolution was included in their packets and Decatur County has complied with all the requirements of setting the budget. The public hearing was held at the last Commissioners' meeting and recommends approval by the Board. Commissioner Davis made a motion to approve the resolution, a copy of which is attached. Commissioner Brock seconded the motion, a vote was taken and unanimously approved.

Consider Approval of Grant Funds. Chairman Stephens recognized the Clerk of Court, Cecilia Willis who stated the sound system at the Courthouse is outdated and it needs to be upgraded. Judge Lanier applied for the Audio and Visual Equipment Grant for the South Georgia Judicial Circuit through The Judicial Council of Georgia American Rescue Plan Act and was awarded the grant. Clerk Willis stated she is only speaking on behalf of Decatur County and not the South Georgia Judicial Circuit. The South Georgia Judicial Circuit was awarded the grant in the amount of \$873,035 and the portion allotted for Decatur County to upgrade the sound system is \$311,000.

Clerk Willis stated the grant stipulates that Decatur County must pay for the sound equipment upfront and be reimbursed from the grant. Two bids were received for the sound system upgrade and S and L Integrated was the higher bid, but it offered more advantages to the sound system. Clerk Willis is requesting approval to proceed with the grant and to accept the proposal from S and L Integrated to move forward on the installation of the new sound system equipment. Commissioner Davis made a

motion to approve the grant and proposal, a copy of which is attached. Commissioner Barber seconded the motion, a vote was taken and unanimously approved.

Consider Approval of Airport DBE Project. Chairman Stephens recognized County Administrator Thomas who stated DBE stands for Disadvantaged Business Enterprise and is an opportunity for disadvantaged businesses to participate in federal funding that we use for airport projects and is a requirement for federal funding for the airport. The DBE plan has to be updated every three years and Taffy Pippin Consulting, LLC will provide the DBE plan as submitted in Passero Associates work order number 23-04. The project has been approved by GDOT and they will participate in the payment of the project and recommends approval by the Board. Commissioner Barber made a motion to approve the project, a copy of which is attached. Commissioner Brock seconded the motion, a vote was taken and unanimously approved.

Consider Appointments. Chairman Stephens recognized County Administrator Thomas who stated Jamie Earp has agreed to serve on the Georgia Pines Board for the unexpired term of Larry Nichols. The appointment starts immediately and ends on December 31, 2023 and recommends approval by the Board. Commissioner Brock made a motion to approve the appointment. Commissioner Anderson seconded the motion, a vote was taken and unanimously approved.

Chairman Stephens recognized County Administrator Thomas who stated there are two terms ending on the Hospital Authority. The term of Wheat Kirbo III is expiring and it is recommended that the names of Wheat Kirbo III, Steve Brock and James Earp be submitted to the Hospital Authority for consideration of appointment. The term of Marvalynn Carroll is expiring and it is recommended that the names of Marvalynn Carroll, Bobby Barber, Jr. and Hunter Boyd be submitted for consideration of appointment.

Commissioner Barber made a motion to approve the nominations for appointment to the Hospital Authority. Vice Chairman Brinson seconded the motion, a vote was taken and unanimously approved.

Consider Approval of Errors & Releases. Chairman Stephens recognized County Administrator Thomas who recommended that the Board approve the errors and releases, stating the Tax Commissioner and the Board of Assessors have approved. Commissioner Brock made a motion to approve the Errors and Releases. Commissioner Anderson seconded the motion, a vote was taken and unanimously approved.

#### COMMISSIONERS/ADMINISTRATOR'S REMARKS

The Commissioners thanked everyone for coming.

#### **ADJOURN**

There being no further business, the meeting, on motion by Vice Chairman Brinson, was duly adjourned. Commissioner Davis seconded the motion, a vote was taken and unanimously approved.

# BUDGET RESOLUTION of the DECATUR COUNTY BOARD OF COMMISSIONERS

Re: Decatur County Budget Fiscal Year July 1, 2023 - June 30, 2024

WHEREAS, the county's fiscal year begins July 1, 2023 and ends June 30, 2024; and

WHEREAS, State law requires that each county operate under a balanced budget adopted by ordinance or resolution; and

WHEREAS, the budget shall be adopted at the legal level of budgetary control which is the fund/department level. That is, expenditures may not exceed the total for any department or office with a fund without the approval of the Board of Commissioners. The Budget Officer, however, shall have the authority to transfer appropriations within a department within a fund from one line item (to another object classification within the same department) to other line items. For the purpose of the administration of this budget resolution, the budget officer shall be designated as the acting County Administrator for Decatur County General Government Departments and the Constitutional Officers for their respective offices; and

WHEREAS, the county staff has prepared a proposed balanced budget stating the anticipated revenues by source and expenditures by department for the proposed fiscal year; and

WHEREAS, the appropriate advertised public hearing was held on June 13, 2023 on the proposed budget.

**THEREFORE, BE IT RESOLVED**, that the Decatur County Board of Commissioners hereby adopts the Fiscal Year 2023-2024 budget attached.

(g) If awarded funds for court-based substance use diversion services, recipient shall (for U.S. Treasury reporting purposes): (1) report the amount of the ARPA funds allocated to evidencebased interventions; and (2) report whether ARPA-funded activities are primarily serving a disproportionally impacted community. See Treasury's Compliance and Reporting Guidance, "Project Demographic Distribution" and "Use of Evidence," pp. 20-21; 33; 37-38; 42; 47 for Such report shall be communicated monthly by letter accompanying the reimbursement requests for applicable expenditures. EC 1.13; 31 CFR § 35.6 (b) (3) (i) (C). (h) If awarded funds for court-based eviction prevention and diversion services, recipient shall (for U.S. Treasury reporting purposes): (1) report the amount of the ARPA funds allocated to evidence-based interventions; and (2) report whether ARPA-funded activities are primarily serving a disproportionally impacted community. See Treasury's Compliance and Reporting Guidance, "Project Demographic Distribution" and "Use of Evidence," pp. 20-21; 33; 37-38; 42-43; 47 for details. #### Section 2. Restrictions

(a) Federally Eligible Uses Currently Authorized by the Executive Branch and the ARPA Committee

Only the following expenditures are currently authorized by the Executive Branch and the ARPA Committee:

- (1) Personnel. Payroll costs for personnel responding to court case backlogs with a primary focus on serious violent felonies; backfilling positions requiring less experience to reassign more experienced staff to expedite the disposition of serious violent felony cases; or personnel administering the ARPA grant. As used in this expenditure category only, "primary focus on serious violent felonies" means more than 50 percent of total personnel costs responding to case backlogs awarded in each calendar year under approved Application section (E) (1) shall be dedicated to responding to serious violent felonies, as defined in OCGA § 17-10-6.1 (a).
- (2) Court-based Eviction, Mental Health, or Substance Use Diversion. Payroll costs for personnel performing court-based eviction, mental health, or substance use diversion services only if: (i) such services respond to case backlogs; and (ii) a subrecipient provides a numerical estimate to the AOC demonstrating that such services will conserve staff time and resources to respond to backlogs of serious violent felony cases, as defined in OCGA § 17-10-6.1 (a). As used in these expenditure categories, "numerical" means containing one or more of the number symbols 0, 1, 2, 3, 4, 5, 6, 7, 8, or 9; e.g., 20 hours of staff time per week, 18 percent of a judge's caseload, or some other numerical measurement.
- (3) Other Program Costs. Reasonable and necessary costs to support a response to court case backlogs with a primary focus on cases involving serious violent felonies or to perform ARPA grant administration, as follows:
  - (i) The purchase of necessary supplies and materials used by personnel funded by the ARPA grant;
  - (ii) The purchase or rental of equipment used by personnel funded by the ARPA grant, including any reasonable and required license, basic operating software, or service needed to use such equipment;
  - (iii) Travel costs of personnel and contractors funded by the ARPA grant traveling between counties in multi-county judicial circuits that are necessary to address the backlog in court cases with a primary focus on cases involving serious violent felonies;
  - (iv) Rental of temporary space for personnel funded by the ARPA grant;
  - (v) Printing, publication, media, or postage costs;

)

- (vi) Jury expenditures for the trial of cases that are part of the case backlog caused by the COVID-19 pandemic;
- (vii) Jury sequestration costs if necessary for jurors in serious violent felony cases;
- (viii) Continuing legal education and professional dues for prosecutors funded by the ARPA grant, as required by the State Bar of Georgia to maintain a law license;
- (ix) Mandatory continuing judicial education for judges funded by the ARPA grant, as required by the Institute of Continuing Judicial Education and uniform court rules;
- (x) Contracts for professional services or per diem to respond to court case backlogs, including services provided by interpreters, senior judges, state paid county reimbursed (SPCR) prosecutors, and court reporters; or to perform grant administration;
- (xi) Mandatory training for victim assistance coordinators and victims' advocates funded by the ARPA grant, as required by law and the Prosecuting Attorneys' Council;

- (xii) Mandatory training for district attorney investigators funded by the ARPA grant, as required by law and the Peace Officer Standards and Training Council;
- (xiii) Audio-visual equipment modernization in existing courtrooms, as provided in the Audio-Visual Equipment Modernization Policy (posted under Quick Links at <a href="https://jcaoc.georgiacourts.gov/arpa/">https://jcaoc.georgiacourts.gov/arpa/</a>); and
- (xiv) Other program costs necessary to address a court backlog caused or exacerbated by the COVID-19 pandemic with a primary focus on cases involving serious violent felonies may be approved by OPB at its sole discretion following a written request for approval by AOC prior to AOC's approval of said costs.
- (b) Federally Eligible Uses <u>Not</u> Currently Authorized by the Executive Branch or the ARPA Committee

All the following federally eligible ARPA expenditure categories (ECs) are <u>not</u> currently authorized by the Executive Branch or the ARPA Committee:

- (3) ARPA grants to municipal courts (pursue ARPA funds from cities before contacting the ARPA Committee), public defenders, or conflict attorneys (see funds allocated to GPDC).
- (4) COVID-19 testing. EC 1.2; 31 CFR § 35.6 (b) (3) (i) (A). Contact the Georgia Emergency Management and Homeland Security Agency (GEMA) for COVID-19 testing assistance.

- (5) The purchase of personal protective equipment (e.g., gloves, masks, and hand sanitizer). EC 1.5; 31 CFR § 35.6 (b) (3) (i) (A). Contact <u>GEMA</u> for personal protective equipment.
- (6) Expenditures to prevent COVID-19 in congregate settings (e.g., plexiglass, cleaning supplies or services). EC 1.4; 31 CFR § 35.6 (b) (3) (i) (A). Contact <u>GEMA</u> for assistance with supplies to prevent COVID-19 in congregate settings.
- (7) Payroll supplements, stipends, bonuses, "premium pay," or any other payroll payments to staff that do not correspond to actual documented payroll time spent responding to case backlogs or performing ARPA grant administration. "Premium pay" is defined in 31 CFR §§ 35.3, 35.6 (c); EC 4.1.
- (8) Except as provided in Section 2 (a) (3) (xiii) of this attachment, long-term infrastructure (i.e., capital) investments in public facilities, such as physical plant improvements, permanent adaptations to existing public buildings, or constructing new facilities to respond to the pandemic or its negative economic impacts. I am pleased to have the opportunity to request funding for courtroom audio and visual equipment for the five-county South Georgia Judicial Circuit. My rural South Georgia circuit is dedicated to providing timely access to the courts; however, the South Georgia Judicial Circuit is experiencing a large backlog of court cases, both criminal and civil, caused by the pandemic.

In order to help address this backlog expeditiously and efficiently, audio-visual equipment acquisition and/or modernization is necessary. The addition or modernization of audio-visual equipment will allow for remote court appearances for many court participants, including attorneys, witnesses, observers, and defendants, which would allow for quicker access to courts and save time and transportation costs. The circuit criminal case backlog will receive priority, as Decatur, Grady, and Mitchell counties have a larger number of incarcerated persons awaiting trial for violent felonies. Thereafter, habeas and other civil matters will benefit from a more accessible court system.
