## Decatur County Board of Commissioners Road Workshop February 25, 2014 6:00 P.M.

Present: Chairman Frank Loeffler, Vice Chairman Dennis Brinson, Commissioner Russell Smith, Commissioner Butch Mosely, Commissioner Oliver Sellers, Commissioner Jan Godwin, County Clerk Beverly King, County Attorney Brown Moseley, County Administrator Gary Breedlove, Public Works Superintendent Dennis Medley.

Chairman Loeffler called the meeting to order at 6:00 P.M.

Chairman Loeffler recognized Road Superintendent Dennis Medley.

Mr. Medley presented the Board with an annual road and bridge report.

#### Mission:

- Provide and maintain a superior road system within Decatur County.
- Maintain effective cost analysis records
- Coordinate with both the State Department of Transportation and the Corps of Engineers

#### Goal:

• Provide the taxpayers of Decatur County with a safe and viable road system.

## Total Roads:

- 227 Paved Roads and 295 Dirt Roads
- 315.95 paved miles and 360.80 dirt miles
- Total 522 roads and 676.75 total miles

Commissioner Sellers requested Mr. Medley to research the dollar amount to pave all the dirt roads in Decatur County as they are without right-of-ways and the possible funding sources; a loan or bond. Commissioner Sellers stated it could possibly save the County money in equipment and personnel.

Commissioner Sellers requested information from Mr. Medley pertaining to a pot hole machine that was previously discussed with the Board of Commissioners. Mr. Medley explained how he presently patches pot holes. Mr. Medley discussed a spray injection patcher that cleans, tacks, fills, and compacts in one continuous operation. A brief discussion followed.

Commissioner Mosely made a motion to allow Mr. Medley to spec out a spray injection patcher to receive prices and bring before the Board at the next Commissioners' meeting. Commissioner Smith seconded the motion. A vote was taken and unanimously approved.

Commissioner Godwin requested the road department be allowed to go on private property to clean up Poitevint Road that leads to Poitevint Cemetery. County Attorney Moseley stated with very few exceptions the County is not allowed to do work on private property. Mr. Moseley stated the Board of Commissioners passed an ordinance to that effect. Mr. Moseley stated the County would need a written request from the property owners and a Hold Harmless Agreement before it can even be considered.

Commissioner Mosely requested that the Public Works Department do better maintenance on the roads and have a no non-sense approach for the employees.

Commissioner Godwin commended Mr. Medley and his staff for quickly responding to her calls for assistance on some roads in her district.

Commissioner Smith and Vice Chairman Brinson also commended Mr. Medley and his staff for their quick responses to their requests.

Chairman Loeffler thanked Mr. Medley for a very informative workshop. Chairman Loeffler called the work session adjourned.
