COMMISSIONERS' BOARD ROOM

TUESDAY, APRIL 9, 2024

PRESENT: CHAIRMAN PETE STEPHENS, VICE CHAIRMAN DENNIS BRINSON, COMMISSIONERS, BOBBY BARBER, JR, RUSTY DAVIS, GEORGE ANDERSON, AND STEVE BROCK, COUNTY ADMINISTRATOR ALAN THOMAS, COUNTY ATTORNEY BRUCE KIRBO AND COUNTY CLERK MICHELLE WEST.

INVOCATION AND THE PLEDGE OF ALLEGIANCE

Chairman Stephens called the regular meeting to order at 9:00 a.m. After the call to order, Vice Chairman Brinson gave the invocation and all those assembled pledged allegiance to the flag of the United States of America.

APPROVAL OF AGENDA

Chairman Stephens requested to amend the agenda by removing item number seven and replace it with executive session to discuss litigation matters. Commissioner Davis made a motion to approve the agenda, with the amendment. Commissioner Barber seconded the motion, a vote was taken and unanimously approved.

SPECIAL PRESENTATIONS

There were no Special Presentations.

PUBLIC PARTICIPATION

There was no Public Participation.

APPROVAL OF MINUTES

Vice Chairman Brinson made a motion to approve the minutes of the Commissioners' meeting held March 26, 2024, as presented. Commissioner Brock seconded the motion, a vote was taken and unanimously approved.

OLD BUSINESS

There was no Old Business.

NEW BUSINESS

Consider Request from Environmental Health – Ansley Johnson. Chairman Stephens recognized Lead Environmental Health Specialist Ansley Johnson who stated he is requesting to increase the fees for Environmental Health Services. Specialist Johnson stated the last fee increase was in 2015 and if the proposed fee increase is approved it will be effective July 1, 2024. The proposed fee increase is comparable to the other counties in the district and has been reviewed by the district committee. Commissioner Barber made a motion to approve the fee increase, a copy of which is attached. Vice Chairman Brinson seconded the motion, a vote was taken and unanimously approved.

Update from Public Defender Office – **Tre McLendon.** Chairman Stephens recognized Public Defender Tre McLendon who gave an overview of how the Public Defender's office operates.

Consider Amendment to Retirement Plan – Ron Rowe. Chairman Stephens recognized Regional Client Manager Ron Rowe who stated an amendment was approved in 2016 for the retirement plan, and the amendment was not implemented correctly. Manager Rowe stated the attached amendment will replace and correct the previous amendment submitted with the Board's approval. Commissioner Brock made the motion to approve the amendment, a copy of which is attached. Commissioner Davis seconded the motion, a vote was taken and unanimously approved.

Chairman Stephens recognized County Consider Engineering Proposal for Generators. Administrator Thomas who stated in the March 12, 2024 meeting, the Board approved the Georgia Emergency Management and Homeland Security Agency grant for generators. A proposal from Watkins and Associates has been provided to perform the surveying and engineering services necessary for the grant in the amount of \$39,000. County Administrator Thomas is recommending approval by the Board. Commissioner Davis made a motion to approve the Proposal, a copy of which is attached. Commissioner Barber seconded the motion, a vote was taken and unanimously approved.

Consider Proclamation - National Donate Life Month. Chairman Stephens recognized June Faircloth who is representing Lifelink of Georgia. and stated April is Donate Life month. Ms. Faircloth stated for years the Board has been requested to recognize April as National Donate Life Month by a proclamation and the Board has approved prior proclamations. Chairman Stephens proclaimed April 2024 as Donate Life month.

EXECUTIVE SESSION - LITIGATION

Vice Chairman Brinson made the motion to enter into executive session to discuss litigation. Commissioner Anderson seconded the motion, a vote was taken and unanimously approved.

After the executive session, the Commissioners assembled back in the boardroom. Commissioner Davis made the motion to enter back into regular session. Commissioner Brock seconded the motion, a vote was taken and unanimously approved.

Chairman Stephens stated litigation was discussed in the Executive Session and recognized County Attorney Kirbo to briefly speak about the pending litigation that was discussed in executive session.

The Commissioners thanked everyone for coming.

RESOLUTION TO AMEND ASSOCIATION COUNTY COMMISSIONERS OF GEORGIA DEFINED BENEFIT PLAN FOR DECATOR COUNTY EMPLOYEES

WHEREAS, Decatur County, Georgia (the "Employer") previously adopted the Association County Commissioners of Georgia Defined Benefit Plan for Decatur County Employees (the "Plan") through an Adoption Agreement that was most recently amended and restated effective as of January 1, 2015:

WHEREAS, Section 16.02(b) of the Plan allows the Employer to amend the Plan with respect to one or more classes of Employees, subject to the consent of Association County Commissioners Defined Benefit Plan Board of Trustees, and certain other conditions;

WHEREAS, the Employer previously amended the Plan to permit a former Participant who has Retired but returns to employment as an Employee to continue receiving his or her Accrued Benefit but also accrue Credited Service and Compensation during the period of reemployment, and for the Participant's subsequent retirement income to be calculated by including Credited Service and Compensation earned during both periods of employment and actuarially adjusting the resulting benefit to account for distributions made after the initial Retirement; and

WHEREAS, the Employer wishes to amend the Plan to permit the current County Administrator's pre- and post-Retirement periods of employment to be treated separately for all purposes, including accruals of Credited Service, Vesting Service and Compensation, so that, upon his second or any subsequent Termination of Employment, the Accrued Benefit earned during each discrete period of employment will be calculated and paid without regard to any previous or subsequent period of employment.

NOW THEREFORE, at a meeting held on the 9th day of April, 2024, the Decatur County Board of Commissioners hereby resolves as follows:

RESOLVED, that the Board of Commissioners hereby approves the attached Plan Amendment #2 effective as of the date set forth therein;

FURTHER RESOLVED, that the Commission Chair is hereby authorized, empowered, and directed to take all further actions and to execute all documents necessary to implement these resolutions.

FURTHER RESOLVED, that any resolution in conflict with this resolution is hereby repealed.

PLAN AMENDMENT #2 TO ASSOCIATION COUNTY COMMISSIONERS OF GEORGIA DEFINED BENEFIT PLAN FOR DECATUR COUNTY EMPLOYEES

THIS AMENDMENT is made and entered into by the Decatur County Board of Commissioners (the "Employer").

WITNESSETH:

WHEREAS, the Employer maintains the Association County Commissioners of Georgia Defined Benefit Plan for Decatur County Employees ("the Plan") for the benefit of its eligible employees;

WHEREAS, the Employer adopted the Plan through an Adoption Agreement that was most recently amended and restated effective as of January 1, 2015;

WHEREAS, Section 16.02(b) of the Plan allows the Employer to amend the Plan with respect to one or more classes of Employees, subject to the consent of Association County Commissioners Defined Benefit Plan Board of Trustees, and certain other conditions;

WHEREAS, the Employer previously amended the Plan to permit a former Participant who has Retired but returns to employment as an Employee to continue receiving his or her Accrued Benefit but also accrue Credited Service and Compensation during the period of reemployment, and for the Participant's subsequent retirement income to be calculated by including Credited Service and Compensation earned during both periods of employment and actuarially adjusting the resulting benefit to account for distributions made after the initial Retirement; and

WHEREAS, the Employer wishes to amend the Plan to permit the current County Administrator's preand post-Retirement periods of employment to be treated separately for all purposes, including accruals of Credited Service, Vesting Service and Compensation, so that, upon his second or any subsequent Termination of Employment, the Accrued Benefit earned during each discrete period of employment will be calculated and paid without regard to any previous or subsequent period of employment.

NOW, THEREFORE, the Plan is hereby amended as follows:

1.

The Plan's previous amendment to designate Employees as belonging to one or more of Classes 1 or 2 shall be restated to read as follows:

"For purposes of the Plan, Employees shall belong to one or more of the Classes described below:

Class 1: Eligible Employees

All Eligible Employees as defined in Section 1.23 of the Adoption Agreement.

Effective Date: August 1, 2018

Class 2: Employees hired on and after August 1, 2018

Employees who are hired by the Employer on and after August 1, 2018.

Effective Date: August 1, 2018

Class 3: County Administrator

The Employee who holds the position of County Administrator as of April 1, 2024."

2.

Section 10.07 of the Plan, Reemployment of Retired Participant, is hereby restated in its entirety to read as follows as to Class 3 Employees:

"A former Participant who Retired, commenced receipt of his Accrued Benefit and returns to employment as an Employee shall continue to receive his or her Accrued Benefit. To the extent otherwise permitted by the Plan, he shall accrue Credited Service, Vesting Service and Compensation during such period of reemployment. Upon his subsequent Termination of Employment, only the Participant's post-Retirement Credited Service, Vesting Service and Compensation shall be taken into account in determining whether the Participant is entitled to a second Accrued Benefit and, if so, the amount of that Accrued Benefit. No election the Participant made as to his original Accrued Benefit shall apply to his second Accrued Benefit, or vice-versa, and the second Accrued Benefit shall not be actuarially reduced for the period during which the first Accrued Benefit was in pay status."

Dear Mr. Thomas:

Watkins & Associates, L.L.C. is pleased to submit this proposal for surveying and engineering related services necessary to design, bidding and construction administration services for the County's Georgia Emergency Management and Homeland Security Agency's grant for the installation of six stand-by power units at various county owned locations. As requested, we propose providing the following engineering services as described in the below scope of services.

Our proposed scope of services as follows:

- O Site visits to include existing power requirements at each of the six locations.
- O Prepare Construction Plans required for the construction and installation of the six stand-by power units including automatic transfer switches, generator pads, electrical panels/racks, etc. Each station will have its own respective electrical one-line diagrams.
- Provide Contract Documents and Specifications for bidding purposes. Bidding documents shall be in accordance with the requirements set forth in the County's award documents from Georgia Emergency Management and Homeland Security Agency.
- O Submit to County for review and approval.
- O Assist Decatur County in advertising for bids. Hold bid opening, prepare Bid Tabulation and Recommendation of Award.

- o Attend Pre-Construction Conference and issue Notice to Proceed.
- o Provide Construction Review Services.
- o Review Contractor's payment request. Prepare any necessary change orders.
- Provide Final Construction Review.

Our proposed fee for the above-described scope of services is based on a *Lump Sum Basis of* \$39,000.00 of which is based on a 6% design fee of the estimated construction costs. This not-to-exceed fee shall include all labor, materials, and equipment necessary to complete the services proposed listed.

On projects such as this, we do ask that the County provide all the necessary support to assist W&A in the performance of the services outlined above. We respectfully ask that the County to:

- > Provide timely overall policy direction for project.
- > Provide power usage reports from service provider.
- > Provide access to each location for inspection.
- Inform Consultant of and assist Consultant with any unusual site conditions.

WHEREAS, more than 100,000 men, women, and children await lifesaving or life-enhancing organ transplants, of which nearly 3,000 reside in Georgia; and

WHEREAS, 46,630, a record number of transplants, occurred in the calendar year 2023 thanks to the generosity of 23,287 deceased and living donors, of which 1,268 transplant patients and 642 deceased and living donors, also a record number, were from Georgia; and

WHEREAS, more than 2.5 million people throughout the country and in Georgia benefit annually from tissue transplantation thanks to thousands of tissue donors; and

WHEREAS, the need for organ, eye, and tissue donation remains critical as a new patient is added to the national waiting list for an organ transplant every 10 minutes and millions more could experience improved quality of life through tissue transplantation; and
