INVOCATION AND THE PLEDGE OF ALLEGIANCE

Chairman Stephens called the regular meeting to order at 7:00 p.m. After the call to order, Randy Williams gave the invocation and all those assembled pledged allegiance to the flag of the United States of America.

APPROVAL OF AGENDA

Commissioner Davis made a motion to approve the agenda, as presented. Commissioner Barber seconded the motion, a vote was taken and unanimously approved.

APPROVAL OF MINUTES

Commissioner Brock made a motion to approve the minutes of the Commissioners' meeting held February 13, 2024, as presented. Commissioner Barber seconded the motion, a vote was taken and unanimously approved.

Commissioner Brock made a motion to approve the minutes of the Commissioners' work session held February 23, 2024, as presented. Commissioner Barber seconded the motion, a vote was taken and unanimously approved.

NEW BUSINESS

Comments from Seth Stroup. Chairman Stephens recognized Seth Stroup who handed out documents he had compiled for the Commissioners and briefly made comments related to the Special called meeting on December 11, 2023 in consideration of the Project Agreement and PILOT Agreement for Project Liberty.

Consider Appointment of Voting Delegate — Opioid Settlement Process. Chairman Stephens recognized County Administrator Thomas who stated in their packet is the information concerning the Opioid Settlement Process. County Administrator Thomas stated the State of Georgia has entered a Settlement Agreement with manufacturers and distributors of opioids that requires forty percent of the State's share of funds (\$191.6 million) to be spent on a regional basis. The agreement requires the creation of the Georgia Opioid Settlement Advisory Commission (GOSAC) and Regional Advisory Councils (RACs), which will help to direct regional funding allocations. County Administrator Thomas stated as a participating local government, Decatur County has been asked to appoint a voting delegate to select the three members of the Georgia Opioid Settlement Advisory Commission and the Regional Advisory Committee members for our region. A meeting has been scheduled for March 26, 2024 at

2:00 p.m. in Moultrie, Georgia and County Administrator Thomas is recommending that Chairman Stephens be appointed as the voting delegate and to attend the meeting on March 26, 2024. Commissioner Davis made a motion to approve Chairman Stephens as the voting delegate. Commissioner Barber seconded the motion, a vote was taken and unanimously approved.

Consider Approval of Errors & Releases. Chairman Stephens recognized County Administrator Thomas who recommended that the Board approve the errors and releases, stating the Tax Commissioner and the Board of Assessors have approved. Commissioner Brock made a motion to approve the Errors and Releases. Commissioner Davis seconded the motion, a vote was taken and unanimously approved.

EXECUTIVE SESSION - LITIGATION

Commissioner Brock made the motion to enter into executive session to discuss litigation. Commissioner Anderson seconded the motion, a vote was taken and unanimously approved.

After the executive session, the Commissioners assembled back in the boardroom. Commissioner Anderson made the motion to enter back into regular session. Commissioner Davis seconded the motion, a vote was taken and unanimously approved.

Chairman Stephens stated litigation was discussed in executive session and no action was taken.
